Bordeaux meeting inspires more progress!

On 5th July 2010, the EURO-URHIS 2 team descended on the French city of Bordeaux to conduct the third in a series of workshops and project meetings as part of the European Commission funded EURO-URHIS 2 project. Solange Menival, a senior Council politician from Bordeaux welcomed the group to Bordeaux, which follows Liverpool and Slovenia in hosting the group of 32 partners from urban areas across the EU.

The objectives of the workshop were to begin discussions on the implementation of urban health data to inform decision making and policy, whilst also discussing progress in all parts of the project and training participants in survey conduct and data entry in light of the forthcoming Adult and Youth Surveys. The meeting was hosted by the National Federation of Regional Health Observatories in France, with the Universities of Liverpool and Manchester taking a lead on organising the programme and content.

After the final session on 8th July, Project Lead, Dr. Arpana Verma commented, "The Bordeaux meeting and workshop has been hugely interesting and ultimately

successful. As the project leader I am delighted at the progress the project and its partners are making as we enter this vital period of the project development."

Following the collection of existing urban health data in March / April



2010 by urban area partners, the next major development in the project will be in September 2010 with the launch of the Adult and Youth Surveys in urban areas across the EU, designed to collect comparable individual level urban health data. Dr Christopher Birt from the University of Liverpool said, "The future looks bright for the project! There is a lot of work for all partners over the coming 6 months with the Adult and Youth Surveys being sent out and then data being collected, but everyone is pulling together at the right time and we are looking forward to seeing the initial results in 2011."



Project Objectives

- * To collect data at urban area level
- * To provide tools for evidence based policy
- * To develop methods for cross-sectional and longitudinal assessment for urban population health, including all relevant determinants of health
- * To validate these tools and methods by using existing population-based registries and databases
- * To apply the tools in the field and ensure they are easy and intuitive to use by policy makers

PROGRESS FROM BORDEAUX

Work Packages pass initial Evaluation 'Health Check'

One of the main purposes of the Bordeaux meeting was to ensure that all partners were maintaining their excellent work in line with the agreement with the European Commission, which is reported via the Interim Report. The Interim Report is not only vital for the success of the project, but also to reassure the European Commission that our partners are on schedule and delivering to a high



standard. Four of the EURO-URHIS 2 work package leaders presented their project work to date and received useful feedback from Work Package 3 (Evaluation). "This was a very useful exercise for all those involved as well as a useful pre-emptive session for all of those who will have to report on progress at a later date" commented Chris White (WP2). The news was overwhelmingly positive and will be reported soon to the European Commission.

Highlighting different approaches to informing urban health policy

With one of the main Bordeaux workshop objectives being to "demonstrate how results of the existing data collection can be used to inform policy," Chris White (WP2) kicked off the discussions with a presentation on EU policy making and legislative processes. This was designed to inform urban area partners of the wider European context in which they are operating, whilst providing some useful tips for engagement at this level. Urban area partners then took the opportunity to present their own urban policy making structures and priorities. This fascinating session highlighted the enormous difference in policy influencing efforts and policy making structures across Europe. Daniel Pope, Work Package 10 Leader commented, "This was a really impor-



tant part of the workshop for the project partners to experience and it just shows the variation in policy making infrastructure between urban areas in Europe. Some of the differences were startling!"


